

GLA43/12 Update on Discretionary Approach to Physical Site Visits for Application Inspections

15 October 2014

Board Paper Reference – GLA43/12 – Update on Discretionary Approach for Physical Site Visits to Application Inspections

1. Purpose of the Report

- 1.1. This paper updates the Board on the GLA's discretionary approach to physical site visits when conducting application inspections, in particular:
 - Reviewing the applications received since the new process was introduced,
 - Explaining the reasons for whether a physical inspection was conducted or not, and
 - Providing an analysis of the new approach.

2. Recommendation

- 2.1. The Board is invited to review this approach in line with its policy in GLA Brief 28.
- 2.2. The Board is also asked to consider whether adjusting the risk factors may reduce further the number of physical sites visits to increase capability and capacity within the GLA to focus on more high risk of harm activities, and whether that may be done without increasing risk.

3. Background

3.1. Following the Red Tape Challenge and approval by the Board, the GLA introduced a revised approach to processing some inspections from 1 October 2013. The GLA now makes an assessment whether a physical inspection should be conducted as part of the application process. The Authority's approach is published in GLA Brief 28 (see Annex A).

4. Applications Since 1 October 2013 – 2 October 2014

- 4.1. As of 2 October 2014, 101 applications have been processed where a decision has been taken as to whether a physical inspection should be conducted or not (60 additional applications since the previous paper GLA41/12 presented to the Board in April 2014).
- 4.2. The criteria and outcome against which the 101 applications were determined appears at Appendix B.

5. Analysis

5.1. Between October 2013 and October 2014 of the 101 applications, 95 applications were put forward for a physical inspection (or 94 per cent) using the criteria published in GLA Brief 28. The remaining six have been granted without a physical inspection. Of the six granted without a physical inspection, three were granted a

- full licence with three granted with Additional Licence Conditions ("ALCs") see paragraph 5.9 for reasons for granting a licence.
- 5.2. Of the 101 applications, 75 have now reached a final licence decision (i.e. whether a licence should be granted or not). 3 applicants cancelled their application. It is important to also take into account the number of cancelled applications as applications may be cancelled because the applicant does not wish to provide the GLA with information or undergo an inspection.
- 5.3. Of the 75 applications where a licence decision has been made, 69 are applications where a physical inspection was conducted. Of those 69 cases, 54 have been granted a full licence (78 per cent), 3 with ALCs (4 per cent) and 12 have been refused (17 per cent).
- 5.4. On review, the GLA could have refused one application without the need for a physical inspection based on the information held (reference 11 in the table at Annex B). However, the inspection did gather additional evidence for refusing the application.
- 5.5. Of the 95 applications put forward for a physical inspection, 23 are still subject to an ongoing inspection or waiting for a licence decision. Where the inspection is ongoing, either the visit has not yet occurred, enquiries are ongoing or the report is being completed.
- 5.6. Of the 95 applications put forward for a physical inspection, all would have been tasked for a visit under the criteria initially presented to the Board in paper GLA 37/8.2 "GLA Application and Inspection Consultation".
- 5.7. The breakdown of the three mandatory inspection criteria are as follows¹:
 - 1 Previously refused or revoked licence holder, or someone identified as previously linked to that business

2 Refused

5 still in progress

Refused 40 per cent from the completed cases

2 Adverse Government check information or adverse intelligence

55 cases in total

35 Fully licensed

8 Refused

Refused 19 per cent or granted 71 per cent with a full licence so far from the completed cases.

- 5.8. A review of the grounds for submitting the application for a visit has confirmed that the physical inspections were justifiable and proportionate based against the criteria published in GLA Brief 28.
- 5.9. Of the six granted without a physical inspection, two have notified the GLA that they started trading in the GLA sectors. Adverse intelligence has been received against two of those licence holders granted a licence without inspection. The GLA is satisfied that the adverse information could not and would not have been gathered from a physical site visit and refers to alleged conduct sometime after the licences were granted. Four of those six applications are well established companies already trading in other sectors which can be seen as a form of Earned Recognition. The fifth and sixth companies were relatively recent set ups. However, from the information received from other Government departments, the GLA was satisfied that a licence could be granted without conducting a physical inspection.

6. Conclusion

- 6.1 The results to date demonstrate an effective and robust process for determining whether Application Inspection is necessary and/or appropriate
- 6.2 Care needs to be taken in any further relaxation of the review criteria so as not to significantly increase the risk of licensing inappropriate applicants.

7. Financial Implications and Budget Provision

7.1 The cost of revoking a licence is likely to be significantly greater than refusing a licence application. This is due to the additional work done by the GLA and partner agencies at all stages of the process. Since May 2012 only 36 percent of the appeals received by the GLA have been appeals against a refusal. Whereas significantly more appeals are received against a decision to revoke a licence. It should also be noted that the current appeal process allows a licence holder to continue to trade until the outcome of that appeal.

8. Organisational Risks

- 8.1 Reducing the number of application inspections without clear criteria for doing so increases the risk of licensing businesses which should not hold a GLA licence and increase the potential exploitation of workers.
- 8.2 There may be reputational risks for the GLA if it is seen to be granting licences to applicants who fail to adhere to licensing standards and thereby unnecessarily expose vulnerable workers to potential exploitative practices

9. Policy Implications and Links to Strategic Priorities

9.1 The inspection and licensing processes are the cornerstone of the framework to prevent rogue operators entering the licensing sector. Allowing a higher degree of risk, without additional sources of information to confirm compliance, could undermine the licensing regime and would reduce the preventative action of the GLA.
