If there is a requirement to show those cases under appeal as a separate list then the options are (a) to publish a list from HMCTS; (b) to include status as a PR search criterion (NB: this is included in the business requirements for LAWS mk 2). Recommendation: No separate list but consideration of HMCTS listings being published on the website - but this is not court practice to do so.
